### **About AsylumConnect**

Co-founded by a gay asylum seeker and trans American at the University of Pennsylvania, AsylumConnect is a 501(c)(3) nonprofit organization providing **the world's first web and mobile resource platform designed for LGBTQ+ people fleeing persecution. We use technology to instantly match LGBTQ+ people fleeing persecution with independently verified safe legal, medical, mental health and social services.**

LGBTQ+ asylum seekers, refugees and other LGBTQ+ people fleeing persecution (such as homeless queer and trans youth) use AsylumConnect's free web and mobile resource platform to instantly match with independently verified LGBTQ+ affirming and immigrant friendly legal, medical, mental health and social services providers. Lawyers, case managers and other direct providers also leverage the free platform to easily gather verified affirming service referrals for their LGBTQ+ clients.

AsylumConnect is available as a free website, mobile responsive web app (accessible via a web browser on a phone), and native iOS and Android mobile apps. The free platform is currently available in 35 U.S. states, Canada (as of April 2019), and Mexico (as of October 2020).

Since launching in Seattle, Washington in 2016, the free AsylumConnect platform has made **75,000+ matches** between LGBTQ+ people fleeing persecution and the vetted affirming services that can help. (\*85% of matches to-date have been made in the United States. For up-to-date information, see the [“Our Impact” page](#) of our homesite.)

### **Why AsylumConnect Is Needed**

In **80+ countries** it remains illegal or fundamentally unsafe to live openly as a LGBTQ+ person.

- Same-sex activity between consenting adults is subject to criminalization in approximately 70 countries
- Of these 70 countries, 31 carry a sentence of 10+ years in prison, and **12 countries still impose the death penalty**
- 12 countries target gender identity through 'cross-dressing' or 'impersonation' laws

As a result, every year, tens of thousands are forced to flee their home countries due to persecution based on their sexual orientation and/or gender identity. Many turn to asylum and refugee protections as a lifeline.

- The U.S. is facing an unprecedented immigration case backlog. The U.S. immigration court system currently has a backlog of over 1 million cases. An [estimated 5 percent](#) of U.S. asylum claims are based on persecution of sexual orientation or gender identity, which suggests there are over 50,000 currently pending LGBTQ cases in America.
- Additionally, [thousands](#) of LGBTQ+ people are seeking asylum in Canada, and the country’s acceptance rate of asylum seekers is the [highest in 27 years](#).
- Since its implementation in December 2018, the Migrant Protection Protocols (MPP) policy has forced [over 70,000](#) asylum seekers to wait in Mexico while the U.S. immigration courts decide on their asylum cases.

The challenge for many LGBTQ+ people fleeing persecution is that discrimination continues even in “safe” havens. Doctors, shelters, lawyers, and the wider social services sector in North America can be unsafe and biased for queer and trans people. LGBTQ+ asylum seekers especially often struggle to access legitimate local services and support, and face increased risk of detention, homelessness, and facing homophobic or transphobic behavior when accessing critical social services. Out of options, many are forced to give up on their legal claim and face deportation to their dangerous home country.

**AsylumConnect is leveraging technology to fill the critical information gap separating LGBTQ+ people fleeing persecution from the safe direct service providers that can help.**

## **How AsylumConnect Started**

AsylumConnect co-founders Sy and Jamie met as college students at the University of Pennsylvania. Sy shared his personal experience struggling to find safe resources during his own U.S. asylum process.

**Despite access to technology, upon arrival in the United States Sy struggled as a gay immigrant to know where it was safe to go for help to meet his basic needs, from finding legitimate pro bono legal representation for his asylum claim to LGBTQ+ affirming health care, mental health support, housing, and educational opportunities. As a trans man from a conservative background, the feeling of not being able to live authentically deeply resonated with Jamie.**

Together, during their senior year at Penn, Sy and Jamie co-founded the tech nonprofit AsylumConnect to extend the first ever digital lifeline to other persecuted and marginalized LGBTQ+ people.

AsylumConnect is founded on the belief that *every* LGBTQ+ person deserves the safety and freedom to live authentically.

### **Verified Service Area Coverage:**

The full AsylumConnect platform is currently available in 35 U.S. states, Canada and Mexico. We also offer a translated international resource page for LGBTQ+ asylum seekers and refugees who are outside of these countries and still in transit.

AsylumConnect's platform currently lists 1,200+ organizations and 4,500+ services vetted by our trained volunteers to be welcoming to LGBTQ+ asylum seekers and other LGBTQ+ people fleeing persecution.

\*Prior to inclusion on AsylumConnect, trained volunteers verify that each direct service provider is: 1) active and legitimate, 2) LGBTQ+ friendly, and 3) accessible to asylum seekers and the undocumented community. Our trained volunteers also re-verify each provider listed on the platform at least once every 6 months for maximum user safety and quality control. ([Learn more.](#))

The most common verified service categories listed on AsylumConnect include: Mental Health, Legal, Medical, Community Support, and Education & Employment.

#### **Additional Platform Features:**

- **Verification (safety):** all direct service providers listed on AsylumConnect are vetted (and re-verified at least once every 6 months) by trained volunteers to be welcoming to LGBTQ+ asylum seekers and other LGBTQ+ people fleeing persecution ([learn more about our vetting process](#))
- **Accessible:** AsylumConnect is available as a free [website](#) and on mobile (via a mobile-responsive web app and native [iOS and Android mobile apps](#))
- **Translation:** available in native English and over 100 additional languages on-demand via Google Translate (the AsylumConnect team is in the process of adding native Spanish translations to the platform for the US and Mexico in 2021)
- **Anonymity:** designed to protect users' confidentiality and privacy online
- **Search filters:** users can easily filter out services that require specific documentation (such as medical insurance, proof of age/income/residence, or a referral) to access
- **Public ratings and reviews:** once logged-in, users can share public ratings (one to five stars) and written reviews on all resources
- **Save and share resources:** once logged-in, users can also save and share their personalized resource list(s) via print, email or another AsylumConnect user account
- **Public resource submissions:** once logged-in, users can "suggest" new direct service providers in the US, Canada and Mexico that they think might be a fit for our platform via country-specific "Suggest New Resource" forms
- **Ownership over their own listing (service providers):** direct service providers who register for a free user account can also "claim" their organization's live profile page on AsylumConnect to help keep their organization's information up-to-date, 24/7

### **Jamie Sgarro, AsylumConnect Co-Founder, inaugural Executive Director & Board Member**



Jamie Sgarro (he/him or they/them) is the co-founder of AsylumConnect and a member of the governing board. He previously served as the organization's inaugural executive director from 2014 to May 2021. As a trans man who grew up in a conservative environment, Jamie remains personally motivated to ensure every persecuted trans and queer person has access to AsylumConnect's vital service. He is currently attending law school with the hope of becoming a civil rights attorney focused on issues impacting LGBTQ+ people, particularly the transgender community.

Under Jamie's leadership, AsylumConnect built a diverse coalition of staff, volunteers, interns, board members, advisors, and established key partnerships to scale its free web and mobile resource platform to reach thousands of LGBTQ+ people in need across North America. After co-founding the organization in 2014, Sgarro raised its first \$500,000 in funding, launched an innovative junior board program for young professionals, secured national news coverage, and earned international recognition for outstanding contribution in social impact as the recipient of the Millennium Campus Network's 2015 Millennium Peace Prize at the United Nations, member of the Clinton Foundation's 2017 CGI U Alumni Honor Roll of social innovators, [2019 Roddenberry Fellow](#), [2020 Forbes 30 under 30 honoree](#) in Law & Policy, and finalist in [Fast Company's 2020 World Changing Ideas Awards](#).

Jamie has been a featured speaker on LGBTQ+ rights and technology for social good, and his work has appeared in national outlets including The HuffPost, Forbes, Teen Vogue, The Clinton Foundation's "Why Am I Telling You This?" Podcast, The Advocate, The Hill, NowThis, and NBC OUT.

Jamie holds a B.A. cum laude with distinction in Health & Societies from the University of Pennsylvania and a M.S. in Management from Northwestern University's Kellogg School of Management.

A native of Annapolis Maryland, Shalawn L James, is a mental health educator, advocate and policy influencer who focuses her work around increasing visibility, equity and access for underserved and marginalized communities. Her two-decade long career has been spent counseling survivors of domestic violence, working with children and adolescents at Milton Hershey School, providing counseling services to abused and neglected children and their families and

advocating and policy reform for the LGBTQI+ community, mentally ill, BIPOC community and justice reform.

Shalawn has spent the last several years in leadership of the statewide Mental Health Association (MHA) for Pennsylvania where she worked directly with State leaders to transform the care, treatments and access to mental health services on both a local and statewide level for BIPOC and LGBTQI+ communities. She serves as a member of many boards including but not limited to the Governor's Appointee (newly appointed to her 2nd Commission) on the Medical Marijuana Advisory Board as a Patient Advocate and the Mental Health Planning Committee, Children's Committee. Shalawn has been the keynote speaker and presenter for Comcast, Keller Williams, South Central Sickle Cell Council, Pennsylvania State University and many more, on a wide range of mental health, and Diversity, Inclusion & Equity topics.

### **Hans How, AsylumConnect Advisory Council Member & Previous Volunteer Vice President**

As a LGBTQ+ asylee, Hans How knows first-hand how difficult it is to find safe help in a new country. He is a frequent speaker on LGBTQ+ rights, and his work with AsylumConnect has been featured in *The Daily Beast*, *The Bay Area Reporter*, and others.



As a gay Asian immigrant community leader, Hans cofounded and campaigned for the historic passage of Proposition C: Commissions For All, a ballot measure that will give all San Franciscans, regardless of immigration status, a voice, representation, and equal rights to serve on city commissions and advisory bodies. After Prop C was successfully passed by voters, Hans was appointed by the Board of Supervisors to serve as the Housing Commissioner to provide oversight of city funds to develop permanently affordable housing in the City and County of San Francisco.

Born and raised in Malaysia, Hans is a proud first-generation college graduate from Wesleyan University, where he earned full scholarships from the Freeman Foundation and the American Malaysian Chamber of Commerce.

Before joining the AsylumConnect Advisory Council, Hans previously served as the volunteer Vice President of AsylumConnect from June 2017 – May 2021.
